
## BRAVO ! NCIC

**F**ourteen years since its formation, the National Cohesion and Integration Commission remains a cause for pride. This past year the Commission has experienced a remarkable upswing in its performance despite the catastrophic global pandemic and intensified elections campaign period.

Steered by the leadership of the Commission Secretary Dr. Skitter Ocharo HSC the NCIC has been able to offer diligent services allowing the commission to thrive in a number of thematic areas even as we trudge through the electioneering year. In the recently concluded 2020/2021 Values and Principles Evaluation report, the Commission not only outperformed its last years' score but also recorded the highest improvement in the overall index from 27.1% to 51.4% making it the MOST improved Government institution.

Over the years, the Public Service Commission (PSC), mandated to conduct annual evaluation on all public institutions, has been carrying out the exercise to ensure good governance, service delivery and accountability in all public institutions. In the report shared with the Commission, the institution excelled in the following thematic areas;

fln regards to service delivery improvement the commission recorded a score of 62.5%, a leap from last inancial years' 0%. This owing to the fact that the NCIC had already reviewed the service charter to Swahili and braille, targeting Kenyans from all walks especially persons with disabilities. The PSC were also happy to note that within the last one year the Commission had conducted Training Needs Assessment, adopted and implemented a sound Organizational Structure in line with Government requirement. The implementation of the Organogram has not only improved service delivery, but it has also paved way for succession planning as well as clear career growth for staff. This indeed is enviable improvement.

## Elections Bila Noma: Conflict Hotspot Mapping Exercise

With six months to the August polls, NCIC has developed several strategies towards ensuring a peaceful electoral process, among them conducting a Conflict Hotspot Mapping exercise across the country. The exercise seeks to map out the likelihood of election violence across the country. As such, NCIC invited peace ambassadors and peace actors in general, to help analyze and understand the context of various communities, counties, regions, and country, and subsequently develop preventive and response strategies that would lead to the realization of an ‘Elections Bila Noma’.

Specifically in line with NCIC’s Roadmap to a violent-free election, the Hotspot Mapping Exercise aims at enhancing substantial capacities on early warning and early response ahead, during and after the 2022 General Elections. Through this exercise, NCIC hopes to build productive partnerships through synergies, particularly with Kenyans– now, during and beyond the imminent elections.

The Commission acknowledges that the lack of trust that exists between the public and government institutions is one of the biggest roadblocks to a peaceful 2022 general election. Through this study, and the recommendations targeted at preventing and mitigating electoral violence as shall be proposed by all the players, to break this barrier and give space for interventions that would forthwith realize an Elections Bila Noma.

The Commission is cognizant of the fact that challenges of securing a **VIOLENT-FREE ELECTION** are enormous, but through actions such as this, it remains confident that this task can easily be achieved, especially through sharing of ideas, challenges, and most importantly, solutions to the issues that ail us as a country, especially around electoral cycles.

The National Cohesion and Integration Commission has called on political parties to embrace issue-based politics and tame their straying members in order to attain violent free elections. Speaking in a conference targeting political parties, state and non-state actors. The two-day conference held on 31st January 2022 aimed at preventing and mitigating violence ahead of the 2022 General Elections. The Commission Vice Chairperson urged the political players to sign the Political Decency and Peace Charter to enhance accountability. Addressing the same meeting convened by the NCIC, Center for Multiparty Democracy Kenya and the International Republican Institute, Commissioner Hon. Dorcas Kedogo encouraged political players to desist from spewing hate and inciting communities against each other, especially on social media platforms.

## MoUs with Global Peace Foundation and Mercy Corps

The National Cohesion and Integration Commission (NCIC) signed Memoranda of Understanding, with Global Peace Foundation and MercyCorps. These partnerships are aimed at aiding the Commission's efforts to deliver a peaceful electioneering period scheduled to take place on the 9th of August 2022. The signing of these MoUs signaled a relationship of mutual benefit by building linkages and synergies of both institutions in the realization of their respective mandates.

Speaking during the exercise, the Commission Secretary/CEO Dr. Skitter Ocharo lauded the Global Peace Foundation and MercyCorps for their strong interest, and unwavering support for the Commission.

Dr. Skitter averred that to attain success in its endeavor to deliver on its mandate, NCIC had achieved a number milestones including: Strengthened peace-building, national values and cultural systems in institutions of learning; Influenced the Cohesion and Integration Agenda in Public Institutions; Enhanced inter and intra communal relations through dialogue and mediation processes; Promoted Compliance and Enforcement of Hate Speech Law; Strengthened Early Warning and Early Response Mechanisms for peaceful elections; and Increased the generation of knowledge on cohesion issues through research.

The Commission Secretary was however keen to mention that despite the aforementioned achievements, the Commission had encountered several challenges including: Budgetary constraints; Limited understanding of the Commission's mandate by the Kenyan public; Limited resources to ensure sustainability of community social contracts and peace agreements; Multiplicity of drivers of conflict and violence; the Statutory nature of the Commission; and the Slow judicial process.

on an electoral political economic analysis that scrutinizes the current electoral environment to identify dynamics of guaranteeing electoral integrity ahead of the August polls.


## NCIC IN THE MEDIA

In a bid to popularize the Commission's Roadmap towards an Elections Bila Noma, NCIC engaged the public on various forums including via mainstream media. On 10th Jan 2022, NCIC Chairman Rev. Dr. Samuel Kobia joined Citizen TV Presenter Trevor Ombija on the Monday Report program to stamp the stand of the Commission on the ongoing hate speech and incitement remarks, especially on the 'madoadoa' remark made by Meru Senator Mithika Linturi in Uasin Gishu county.

The Chairman categorically expounded on the issue of Senator Linturi's remarks, saying his case held more weight due to the context and place these remarks were made. He went ahead to address the claims that NCIC was using double standards when dealing with hate speech case.

On this, the Chair noted that, 'Looking at the list the Commission has dealt with, involving those accused of hate speech, it cuts right across both political divides. We have dealt with people according to how and the context within which they have expressed hate speech'.

Rev. Dr. Kobia also added that the use of the term 'madoadoa' in Eldoret and Uasin Gishu at large evoked memories of the 2007/2008 post-election violence, terming it as part of ICC lexeme. He assured the public that NCIC shall continue to discharge its mandate without fear of intimidation and interference.

On 25<sup>th</sup> January 2022, NCIC Commissioner Hon. Eng. Philip Okundi was invited for a live interview on KBC TV, with the News-check programme.

During the interview, the Commissioner expounded on the looming issue of hate speech-related cases, while addressing political intolerance as an element for hate speech. He used the opportunity to explain the NCIC Roadmap, while assuring Kenyans of a peaceful electioneering process.

“We are monitoring potential causes of violence between persons across the country, including among various clans with the aim of addressing the root causes of hate speech, negative ethnicity and violence,” said the commissioner while expounding on the Commission's efforts to monitor hate speech. The Commissioner went on to add that NCIC has marked hot spot areas likely to violence, as well as increased sensitization programs in the said areas.

He urged Kenyans to restrain from engaging in explosive politics, calling them to maintain peace and ignore influence by politicians to engage in violence.

On the same breadth, Commissioner Dr. Danvas Makori received an invitation to NTV's With All Due Respect programme by James Smart on 11th January 2022.

The Commissioner emphasized on the Commission's chief mandate as a peacebuilding and reconciliation body, rather than as an investigator. He also cited the issue of separation of power, keenly pointing out that government bodies work as a unit to ensure convictions for law-breakers.

Dr. Makori also added that in its quest to provide equal opportunity for all, NCIC has been holding grassroots meetings with the people, to establish the root cause of inequalities.

## NCIC step up Measures to curb Hatespeech

**B**etween the months of December 2021 and January 2022, the attention of the NCIC was drawn to reckless remarks. The Commissioner went on to add that NCIC has marked hot spot areas likely to violence, as well as increased sensitization programs in the said areas.

Senator Mithika Linturi made incitement remarks where he used the word madoadoo to refer to opponents' supporters. Madoadoo has a pejorative connotation in the country that evokes dark memories of the horrific incidents of the 2007-2008 post elections violence.

These politicians have since been summoned by the NCIC to appear before the Commission and record statements as well as follow other investigative procedures. Some of the cases are in the courts awaiting further action.

The NCIC has however taken several measures to curb and contain hate speech including; These tremendous efforts to curb hate speech and the efforts include:

- NCIC has proposed amendments in the NCI Act. These amendments such as among other things the penalty to hate speech, tackling hate speech on social media and admissibility of electronic evidence. NCIC urges parliament to give due consideration to the proposed amendments.
